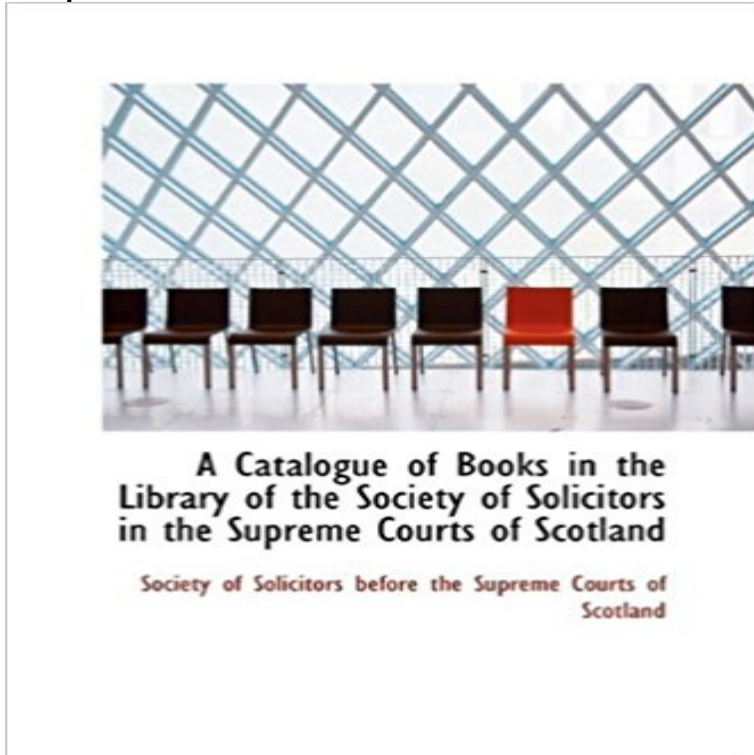


# A Catalogue of Books in the Library of the Society of Solicitors in the Supreme Courts of Scotland
