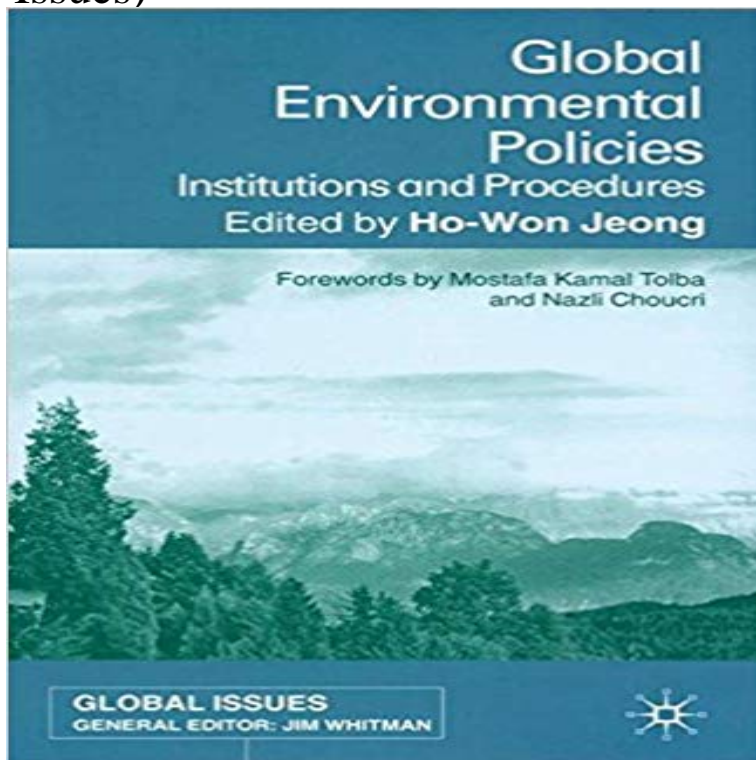


Global Environmental Policies: Institutions and Procedures (Global Issues)
