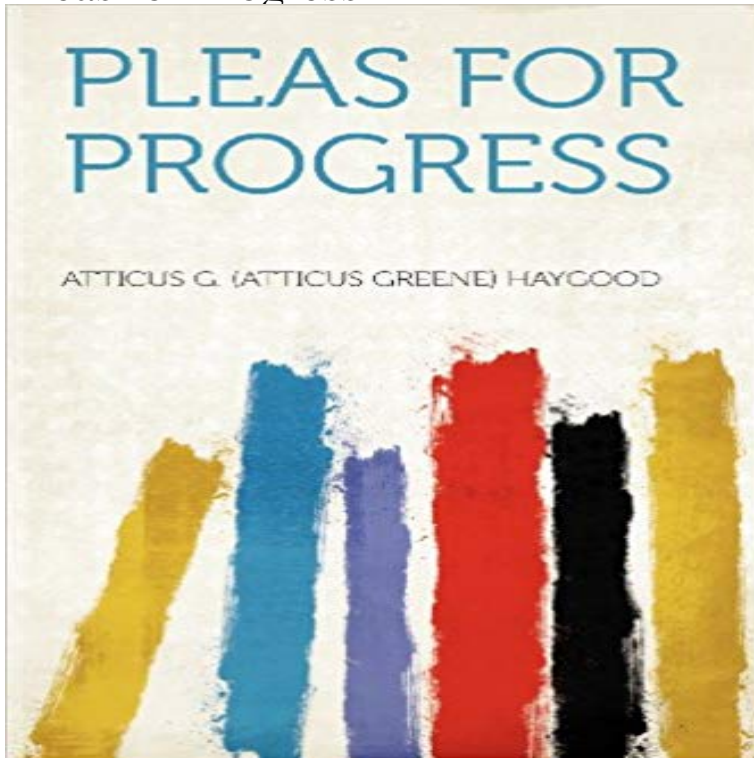


## Pleas for Progress
