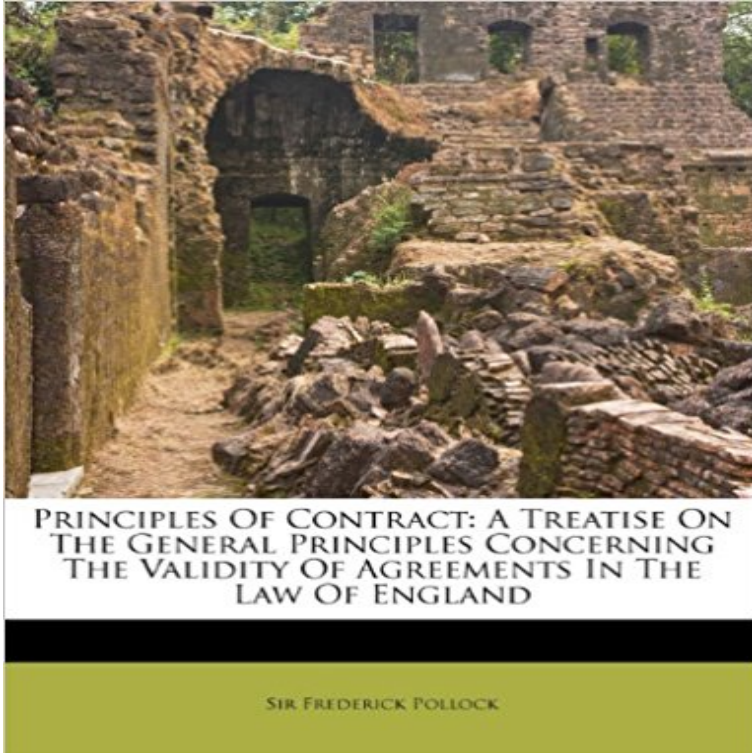


# Principles of Contract: A Treatise on the General Principles Concerning the Validity of Agreements in the Law of England
