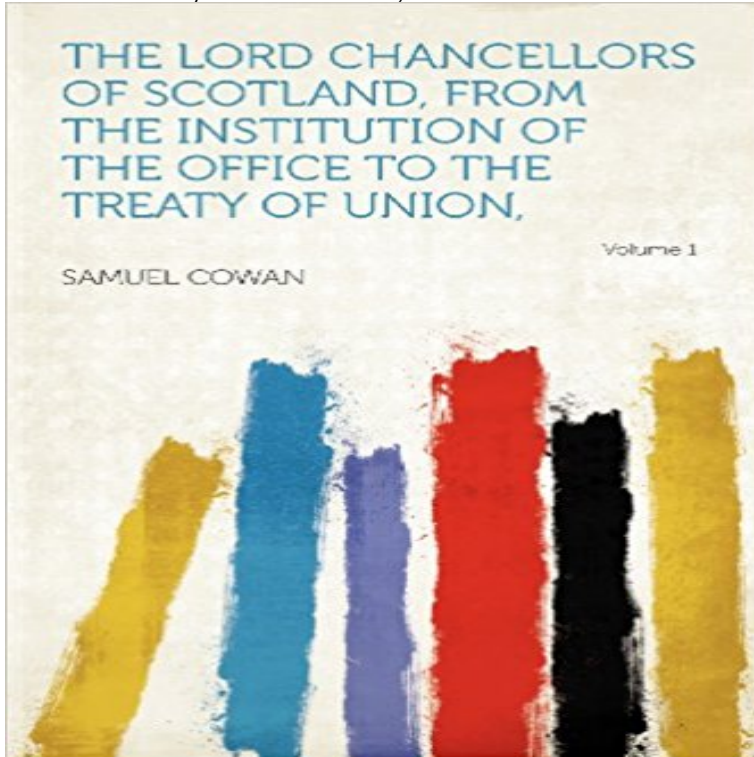


The Lord Chancellors of Scotland, From the Institution of the Office to the Treaty of Union, Volume 1
