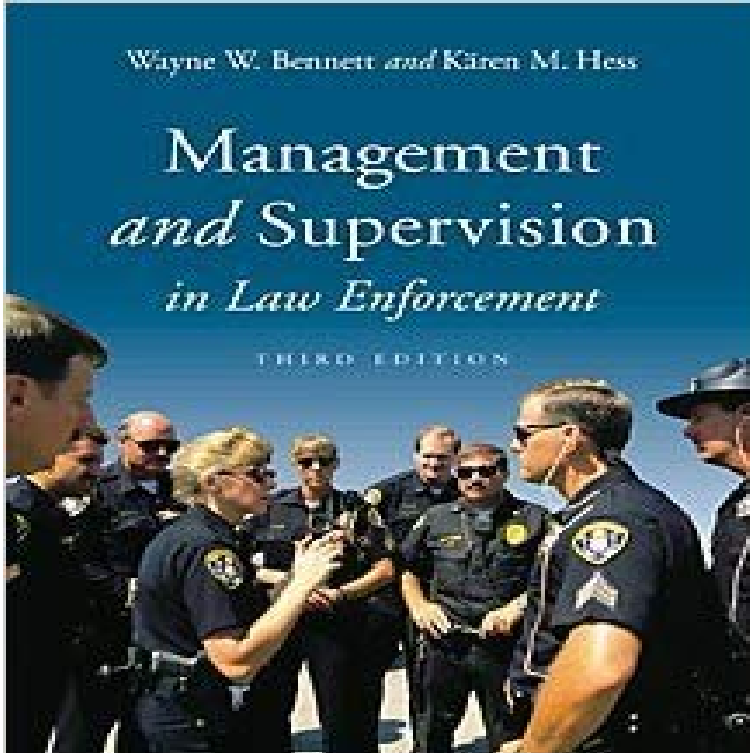


# Management and Supervision in Law Enforcement (Non-InfoTrac Version)
